



F-DPA-M grade of metallized BOPET film having metal deposit layer on one side and other side untreated standard surface. This grade of metallised polyester film is available in optical density ranging from 1.4 to 3.0. The wide range of optical densities gives choice to the customer to use the product for diverse range of applications. The metallization is available on plain side (MU) or on corona treated side (MT), as specified by the customer. The bond strength between the metal and the film is a minimum of 100 gm/25mm when metallized on the Untreated surface & a minimum of 130 gm/25mm when metallized on corona surface.
