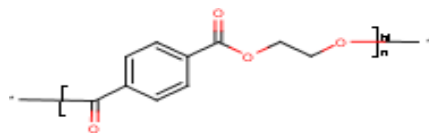

5.0 FIRE-FIGHTING MEASURES

6.3 Methods and material for containment and cleaning up

6.3.1 For containment:

Contaminated protective clothing should be segregated in such a manner so that there is no direct personal contact by personnel who handle, dispose, or clean the clothing. - Film rolls should be moved only with equipment designed for the purpose as film rolls and pallets are heavy. Film edges are sharp and may cause cuts/wounds, handle with most care.

Measures to prevent fire:

- Stop the fire spreading, call the Fire brigade immediately, evacuate non-essential personal. Protective clothing's, goggles and self contained breathing equipment should be made available for fireman.
- Keep away from ignition sources.
- Observe the general rules of industrial fire protection.

7.2 Conditions for safe storage, including any incompatibilities

Technical measures and storage conditions:

- Need to be stored in a close warehouse and should not be exposed to direct sunlight or light sources and from humidity. It is recommended to store below 35 °C in dry place.
